Feeding America has always had compliance and best practice agreements with its Food Banks

FA recently embarked on developing new Agreements, with input from Food Banks, PDOs, Food Bank State Associations and Produce Cooperatives

A Charter was also established





Charter Highlights:



We believe that **no one** should go hungry, ever.

We believe there is **enough food** in America for all.

We believe in providing access to food AND fostering collaborative solutions with partners in and out of our Network to address hunger's root causes.

We believe that **equity is at the core of ending hunger** and that when we intentionally address inequities faced by people **most** impacted by food insecurity, everyone facing hunger benefits.

We believe people facing hunger best understand the realities of food insecurity.

We believe the actions we take to advance our vision will be iterative, and our understanding of optimal approaches will evolve.

We believe each step builds upon and honors our history.

New Agreement of Note for Agency Partners:

Data Sharing

Network-wide data collection, data analysis, and data sharing capacity relating to operational performance needed

Essential to effective planning, collaboration, operations, and resource sharing across the Network in alignment with the Network Charter.

Such a capacity will facilitate the Network's broader anti-hunger and antipoverty research and initiatives.





New Agreement of Note for Agency Partners:

Service Area Assessments

County-level assessments every three years to identify communities with highest food insecurity and lowest food distribution.

Develop an operational response plan that:

A. Includes strategies to provide more resources to areas identified in assessment

with highest need/lowest food distribution

B. Is informed by people experiencing hunger

C. Addresses race and place-based disparities

Introduces concept of proportional distribution of food bank's resources to people facing hunger in your service area

Assessment tool provided by FA or use own (Houston Food Bank may devise their own)





Equity over Effectiveness

Food Bank resources are limited.

Therefore, **food banks** must deal with the conflict between

• Being **equitable** (working so that each individual in need has the same likelihood of being served)

and

• Being **effective** (serving the maximum number of people in need).

For Food Bank equity work, Feeding America is focusing first on RACE & PLACE

- Why Race? Because a person cannot change this about themselves. So, food banks may need to change priorities, resource allocation, practices to make access equitable
- Why Place? Rural takes longer and is more expensive. But needs to have equity as well.


